**FREQUENTLY ASKED QUESTIONS (FAQ)****A. GENERAL**

1. **When is the deadline for payment of SEM 1 2025/2026 fees before the barring process?**
  - i. Senior students local & International (Non-sponsored and PTPTN students) need to pay at least minimum payment before being allowed to register. Due date for senior student to register SEM 1 2025/2026 is **17/10/2025**
  - ii. Non -sponsored students and PTPTN students who has registered SEM 1 2025/2026 need to pay the remaining fees: before or on **23/11/2025 (week 7 of lecture)**
  - iii. Sponsored students who has registered SEM 1 2025/2026 need to pay the remaining fees: before or on **11/02/2026 (week 18 of lecture)**
  
2. **I/my family have financial problems and are having difficulty paying fees this semester.What do I need to do?**
  - i. Contact/meet with the Supervisor/Academic Advisor to discuss the problems encountered  
*Or*
  - ii. Find for a guarantor among UMPSA staff. The Guarantee Form can be obtained by email to the Student Finance Division at [ramlee@umpsa.edu.my](mailto:ramlee@umpsa.edu.my) or [collection1@umpsa.edu.my](mailto:collection1@umpsa.edu.my)

  - Emails sent must state the name, student ID, telephone number to contact and financial problems in detail
  - Emails must be sent no later than week 4 of the lecture to facilitate assistance and quick response/advice given before the payment period ends which can result in students being deferred.

## **B. NON SPONSORED STUDENT AND PTPTN STUDENT**

**5. I am a non-sponsored student/PTPTN student, when do I have to pay SEM 1 2025/2026 fees?**

- i. Senior students local & International (Non-sponsored and PTPTN student) need to pay at least minimum payment before being allowed to register. Due date for senior student to register SEM 1 2025/2026 is **17/10/2025**.
- ii. Remaining fees: Before week 7 of lectures and last before week 10 of lectures
  - Payment deadline before barring process : **23/11/2025**
  - Payment deadline before deferment process : **21/12/2025**

**6. I am a registered student who does not have a sponsor/PTPTN student, if I do not pay the fees within the stipulated period, what is the effect on me?**

**7. I am a registered student who does not have a sponsor/PTPTN student, if I make payment for remaining fees after 21/12/2025, will I still be deferred?**

Yes. Students need to plan the payment. The university management will maintain the deferred status of studies and any appeal is not allowed. Students can continue their studies in the following semester.

**8. I am a registered student without sponsorship/PTPTN student and do not have a final exam / research mode student in SEM 1 2025/2026. Will my studies be deferred if I do not pay the remaining fees by 21/12/2025?**

Yes. All students are subject to this rule.

**9. If my studies are deferred, do I have to pay the full fee?**

No. Deferred students are required to pay Other fees and hostel fees only. Tuition fees will be waived.

**C. SPONSORED STUDENTS**

**10. I am a registered and sponsored student, when is the deadline for my sponsor to pay SEM 1 2025/2026 fees to UMPSA?**

Before or on **11/02/2026**. Barring process is on **12/02/2026** and applicable to all sponsored students who still have outstanding. Kindly refer to question and answer No. 12 below to get details effect of barring.

**11. I am a registered and sponsored student, however the sponsor credits all the sponsorship money to my account. When is the deadline for me to pay the fee to UMPSA?**

- i. Students need to make sure that they have uploaded the sponsorship document in the student ecomm system> Financial Info> Sponsor Document. Sponsor must be from an authorized organization only. If there is no sponsorship information in the system, we will assume the student is without sponsorship. Students without sponsors need to pay at least minimum payment before being allowed to register
- ii. Students need to ensure that sponsorship data has been recorded in the system. (please check at e-comm> Financial Info)
- iii. The deadline for payment of Sem 1 2025/2026 fees for sponsored students before barring process is before or on **23.11.2025**. Hostel fees need to pay in full before being allowed to register.

**12. I am a registered and sponsored student, if I do not pay the fees within the stipulated period, what is the effect on me?**
